<sup>8</sup> Norway resettled 150 Syrians from Turkey since 4 April 2016 by applying the standard operating procedures for resettlement agreed with Turkey in the ambit of the 1:1 scheme. The number of resettlements to Norway in the context of the 1:1 scheme is not counted against returns of Syrians from Greece.

<sup>9</sup> Sweden resettled 1,900 people in 2015 under its national programme, outside of the 20 July 2015 scheme.

<sup>10</sup> By June 2016, a total of 3,439 people were resettled to the UK under the existing UK national resettlement schemes.
